Washington school finance is taking on a new face. With implementation of the prototypical school model in the next biennial budget, the new language and structure of school finance is expected to make funding less mysterious, school board choices more transparent and outcomes more accountable to the public.

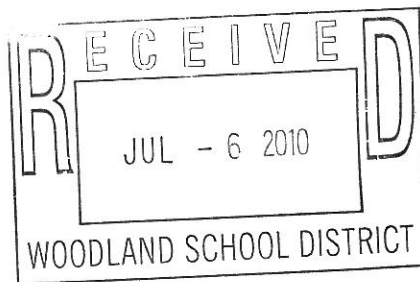
